# **EXHIBITION RULES & REGULATIONS**

These rules and regulations are a part of the application and contract for exhibit space. By signing the contract, an exhibitor agrees to abide by these rules and regulations. The Louisiana Association of Chiefs of Police, (LACP) shall have full power to interpret or amend these rules and regulations. The exhibitor agrees to abide by any rules or regulations that may be adopted hereafter by LACP. The rules and regulations become a part of the contract between the exhibitor and LACP. They have been formulated in the best interest of the exhibitors. The LACP respectfully asks for the full cooperation of the exhibitors in complying with these rules and regulations. Any points not covered are subject to the decision of LACP.

# 1. Set-up and removal of exhibits

#### Exhibit set up:

Monday, July 14 1:00- 5:00 pm.

# **Exhibit dismantle:**

Wednesday, July 17 3:00 p.m.

#### 2. Show Hours

Tuesday, July 15 9:00 am - 4:00 p.m. Wednesday, July 16 8:30 a.m - 3:00 p.m.

### 3. Proper use of exhibit space

Exhibitors may not reassign, sublet or allow other companies to use the whole or a part of the space assigned to them. This rule will be STRICTLY ENFORCED. Exhibitors may not display or advertise any goods or services not manufactured, distributed or otherwise provided by the exhibiting company during the normal course of business.

# 4. Additional services available

You will receive information from the exhibit company, outlining instructions to and order additional equipment or furniture.

# 5. Liability

The Louisiana Association of Chiefs of Police (LACP) shall not be liable or responsible for any damages that may occur to the exhibitor, or to the exhibitor's employees, agents, or guests. Any damage to the goods or other property of the exhibitor for any loss or injury, and all claims for such injuries are hereby waived. The exhibitor is responsible to protect and provide the security for its exhibit, demonstration, goods, materials and/or equipment during conference times. The exhibitor is responsible for

taking all measures necessary to protect other parties and property from any harm, which might result from or be caused by its exhibit, demonstration, goods, materials, and/or equipment. The exhibitor shall be solely liable for any and all damages, costs or expenses which the exhibitor may incur, suffer, or be required to pay by reason of injury to persons or loss of or injury to property which may be caused by or result from any act of omission on the part of the exhibitor, or caused by or results from any demonstrations or exhibit of the exhibitor.

#### 6. Insurance

The exhibitor shall secure, furnish and maintain insurance which must be in effect during all periods of the exhibitor's participation in the exhibition, including, but not limited to, the exhibition itself and the preparation, set up, and dismantling of the exhibition.

# 7. Cancellation and Relocation

The Louisiana Association of Chiefs of Police reserves the right to cancel or relocate the event. If the LACP cancels or relocates the event due to circumstances within the LACP's control, the liability shall be limited to a refund of payment for rental costs paid by the exhibitor in accordance with the payment section of the agreement. In the event that the LACP has no control over the cancellation or relocation of the exhibition, the LACP has no liability of any kind but may, in its discretion, refund any payments for rental costs paid by the exhibitor. In any event, the LACP's maximum and sole liability, if any, to the exhibitor in the event of cancellation or relocation shall be for the return of the rental fee, or a portion of the fee, as the LACP, in its discretion, determines.

# 8. Rejection of application

The Louisiana Association of Chiefs of Police reserves the right to cancel or refuse rental or display space to any person or company whose conduct or display of goods is, in the opinion of the Conference Committee, incompatible with the general character and objectives of the exhibition.

# 9. Payments & Refunds

To ensure space in the exhibit area, full payment must be received in the LACP office no later than June 24, 2025. Any vendor who has not paid will NOT be allowed to set up. Refunds will be issued in full if exhibitor cancels no later June 24, 2025. 50% refund will be issues to those who cancel between June 25 and July3, 2025. Cancellations after July 3, 2025 will not be refunded. All cancellations must be received in writing.
